Request

We received your request on 13 September 2024 for the following information:

- 1. How many people, not households, are currently on the Social Housing Waiting List?
- 2. How many people, not households, are currently deemed to be in housing stress?
- 3. How many people, not households, currently have FDA status?
- 3a. Of those people with FDA status, what is the breakdown by (i) age, (ii) household type and (iii) local government district?
- 4. How many people, not households, are currently being accommodated in non-standard accommodation?
- 5. What was the total cost spent on non-standard accommodation from 1st April 2023 and 31st March 2024?

Your request has been handled under the Freedom of Information Act 2000 (FOIA).

Our response

Waiting List statistics are produced quarterly, so the most recently available are as at 30th June 2024. The figures must be read with the accompanying notes.

1. How many people, not households, are currently on the Social Housing Waiting List?

As at 30th June 2024, there were 47,936 households on the waiting list which equates to 88,880 people.

In the twelve months to end June 2024, there were 5708 allocations to applicant households on the waiting list. This equates to 10,687 people.

2. How many people, not households, are currently deemed to be in housing stress?

As at 30th June 2024, there were 36,137 households who were deemed to be in housing stress on the waiting list. This equates to 67,890 people

3. How many people, not households, currently have FDA status?

As at end June 2024, of the 47,936 households on the waiting list, 30,069 of these had been awarded FDA status and this equates to 58,241 people.

3a Of those people with FDA status, what is the breakdown by (i) age, (ii) household type and (iii) local government district?

The Housing Executive assess cases on the circumstances of the head of household. The FDA household figures are provided below for context, alongside the figures for total number of people within FDA households, broken down by age, household group and Local Government District.

In respect of the above figures, please note the following caveats:

- The figures are based on applicant households only, in line with normal reporting of applicant households on the waiting list. Transfer applicants are already housed and are not included.
- FDA refers to Full Duty Applicants these are applicants accepted as being homeless, to
 whom the Housing Executive owes a duty under the Homelessness legislation, Article 10(2)
 of the Housing (NI) Order, 1988 to "secure that accommodation becomes available for his/her
 occupation".
- Allocations data is for the preceding 12-month period to 30th June 2024.
- Household make up / grouping is recorded at point of application and may not reflect the current composition of the household. Note that applications are assessed on the circumstances of the head of household.
- Social housing waiting list and allocations data held by the Housing Executive, form part of the Northern Ireland Housing Bulletin, which is published quarterly as a National Statistic by the Department for Communities. Therefore, to avoid breaches of the code of practice for statistics, the most recent data provided is based on the most recently published data (end June 2024).

Q4) How many people, not households, are currently being accommodated in non-standard accommodation?

As of 30th June 2024, there were 777 people placed in in non-standard temporary accommodation.

Information on Homelessness is released on a regular basis and can be found on the DfC website here. The current data release covers the period up to 30th June 2024. As a result, the Housing Executive cannot provide the information requested at the time of this request as this is currently exempt under FOI Act Section 22 -Information intended for future publication.

As this is a qualified exemption, we have considered the Public Interest Test.

Public interest factors in favour of disclosure: Promoting transparency, openness, accountability and understanding about how decisions are made.

Public interest factors in favour of maintaining the exemption: The information requested is due to be published on the Department for Communities website as part of the forthcoming data release in December 2024. As this information is of notable interest to the wider public, it is important that it can be accessed by all at the same time in an accurate form. This is in line with the Code of Practice for Statistics.

Outcome of the public interest test

After weighing up the competing public interest considerations, it is reasonable in all the circumstances that the information should not be disclosed until the future intended publication and that the public interest in maintaining the exemption outweighs the public interest in disclosure.

Q5) What was the total cost spent on non-standard accommodation from 1st April 2023 and 31st March 2024?

The table below details non-standard temporary accommodation costs for the period 1st April 2023 and 31st March 2024.
